##### **Please read the following information carefully:**

- If you enter into an online Agreement(s) with EkonomX, you will not be required to submit a paper application. An electronic record will evidence the entire agreement between you and EkonomX. However, you must consent to the use of an electronic record and must read the EkonomX Terms of Use, EkonomX Policies and Procedures and the EkonomX Compensation Plan, and electronically acknowledge below that you have read these documents.
- To access these documents and submit your online Applications, you will need a personal computer or Mac with Internet access and operational Internet browser software.
